# Minutes of Postling Parish Council Meeting held on Wednesday 22 May 2019 in Postling Village Hall (following Annual Meeting of the Council).

- 1. There were no declarations of interest on Agenda items.
- 2. **It was resolved** to accept the Minutes of meeting held on 27 March 2019 which were signed by the Chairman.
- 3. Matters arising from Minutes of previous meeting: Parish Meeting held on 24 April to view Otterpool Park proposal documents attended by 16 parishioners and members of the council.
- 4. **To consider** Planning Applications received since last meeting, circulated to Councillors for comments, outcomes of deliberations, and to consider any further applications received since this agenda was published:
  - a. Y19/0257/FH Otterpool Park development, Ashford Road, Sellindge

The deadline for comments from the Council has been extended from 27 May to 10 June.

An Extraordinary Meeting will be held on Wednesday 5 June 2019 to compile the Parish Council's response to this application.

Cllrs Frank Hobbs and Christine Hobbs attended a F&HDC meeting on 21 May for parishes bordering the Otterpool Park development where infrastructure including water supply was highlighted. It was reported that Affinity Water can supply the first 1500 homes on the current supply with the Paddlesworth main upgraded to supply future homes; this main runs through Postling parish.

## b. Y18/1513 Wents Cottage, Sandling Road, Postling

Change of use of land from scaffold yard to residential curtilage and erection of a detached garage outbuilding, following demolition of existing buildings associated with scaffold yard. PPC No objection. Awaiting F&HDC decision.

## c. Y18/0913/FH Stour Rise, Staple Lane, Postling

Change of use of the land for the keeping of horses and erection of a stable building.

PPC No objection. F&HDC Approved with conditions.

Clerk to query new position of stable as council was not informed.

## d. Y18/1300/FH Pent Farm, Pilgrims Way Postling Hythe Kent CT21 4EY

Reserved matters application for the erection of a permanent agricultural dwelling being details pursuant to outline application Y17/0650/SH (details relating to landscaping, scale, appearance and layout).

#### and Y17/1621/SH Pent Farm, Pilgrims Way Postling Hythe Kent CT21 4EY

Erection of a dwelling being details pursuant to outline planning permission Y17/0650/SH (details relating to layout, scale, appearance, means of access, and landscaping), together with discharging planning conditions 4, 5, 6, 7, 8, 9 and 10.

PPC No objection.
