## Minutes of Postling Parish Council meeting held at Postling Village Hall on Tuesday 26 November 2024 at 6.30pm

1. Attending: Chairman Frank Hobbs, Cllrs Helen Calderbank, Christine Hobbs, Rob Lye, Daniel Shaddick, George Burgess, Parish Clerk Clare Hamilton, District Cllr Elaine Martin, County Cllr Susan Carey, District Cllr Jenny Hollingsbee, and two members of the public. Apologies: Cllr John Pattrick.
2. **It was resolved** unanimously to accept the Minutes of the meeting held on 24 September 2024.
3. There were no Members' declarations of interest on Agenda items.
4. Public Participation session  
A parishioner raised concerns about construction traffic from the Pentland development at Lyminge consistently using Sandling Road. A recent event with a bus and concrete mixer caused major problems. The council will write to Pentland and to FHDC Planning to ask them to review traffic access restrictions in Building Regulations and Site Management Access Plan.
5. Matters arising not included on the Agenda  
A number of parishioners are concerned at the inconsiderate parking for the nursery drop offs/pickups and for the safety of the children. Verges are being damaged by parked cars and neighbouring properties' access restricted. Chairman of Village Hall is aware and will be contacting the nursery.

FHDC are looking for a strategic partner, this will be out for tender in the spring. Conversations are being held with Homes England who own 10%.

There will be a pre-application consultation on the new reed-bed wastewater treatment plant in Sellindge in December, then the planning application is to be submitted.

## Appendix Reports from District and County Councillors

### District Councillor Elaine Martin

#### Lyminge Age UK

I learnt on Friday afternoon that a decision had been made to close the Age UK Lyminge hub. This is a great loss to Lyminge and the surrounding villages. The decision was taken because the cost of running the facility was unsustainable and they had been making a loss on running the services there. Dementia support will still be available in Hythe.

#### Free Christmas parking in Folkestone

F&HDC are once again providing free festive parking in Folkestone town centre. Charges in Folkestone & Hythe District Council car parks and on-street pay and display bays are being waived on the three Saturdays leading up to the big day: Saturday 7 December, Saturday 14 December and Saturday 21 December.

#### Winter Fuel Payment

As I am sure you will have heard, the Government is stopping the Winter Fuel Payment for any pensioner who is not in receipt of Pension Credit. If you are of pensionable age, or know someone who is, please check to see if you can apply for Pension Credit. If you are in receipt of a benefit, you will be automatically eligible for the Winter Fuel Payment and may also be able to get help with your council tax. The application form is available on the Council's website and can either be filled in online or downloaded and returned by post. Friends and families can help by checking with relatives and helping with filling in the application form. There is still time to apply, the deadline for applications for Pension Credit and to be able to receive the Winter Fuel Payment is 21 December 2024.

#### Otterpool Park

Progress in discussions with Homes England has been very slow. However, since the budget and some personnel changes at Homes England, we have seen a renewed determination from Homes England to collaborate.

## F&HDC corporate plan

The consultation on the corporate plan has been completed, with 550 responses received, about a third of these were from younger members of the community. This is a really good response rate as these things go, so many thanks if you returned the online questionnaire.

## District Council Meeting

For the first time ever, the October meeting of the full District council was successfully held outside of Folkestone. The Marsh Academy, New Romney was a fitting venue for this first meeting. It is hoped that the full District Council meeting will continue to move around to various locations throughout the District to encourage more members of the public to attend.

## Decarbonisation Award

Following a very successful refurbishment of Council homes, the F&HDC Asset and Social Housing Decarbonisation staff were judged to be a top team at the recent Kent Housing Group Excellence Awards winning the Asset Management category. Ross House, a previous commercial property in Folkestone, is part of a 425 works programme, and had installation of cavity walls, under floor and loft insulation, ventilation, double-glazed windows, new external doors, high heat retention storage heaters, as well as the installation of air source heat pumps and solar PV panels. The work has reduced the tenants carbon emissions which benefits us all.

## National NHS review

Following the recent independent review of the NHS, the government has launched a national engagement exercise called '*Change NHS: A health service fit for the future*: a national conversation to develop the 10-Year Health Plan'. ## District Councillor Jenny Hollingsbee

**Age UK Hythe & Lyminge** – it has just been announced that the Lyminge Centre will close at the end of February. I have been in touch with the Chief Executive who confirmed that the Centre has been loss making for some and it has become impossible to continue running services from Lyminge. The Dementia Clinic will continue until February but then will probably transfer to Hythe, subject to funding as the Clinic receives no external funding and is subsidised through other services and reserves which is unsustainable.

**Gift card Scams** - There has been a rise in scams involving people being requested by criminals to purchase gift cards from stores. Gift card scams start with a call, text, email, WhatsApp or social media message. Scammers will say anything to get you to purchase gift cards, like Google Play, Apple, Steam, iTunes, or Amazon cards Never Assume - If you get a message from anyone claiming to be a friend or family member, or someone claiming to be from a reputable organisation such as HMRC, a bank, or the police, and you are asked to purchase any gift cards – STOP! – it will be a scam. Contact your Bank immediately, which you can do by calling 159 and report it to Action Fraud at [www.actionfraud.police.uk](http://www.actionfraud.police.uk) or call 0300 123 2040.

**Rural England Prosperity Fund** – it has just been announced that this fund has been suspended as it is highly likely that the applications still to be assessed will, if granted, utilise the remaining funds.

**Home Essential Fund** - is a limited scheme to support low income households with energy efficient solutions to help reduce their costs and supply more efficient items to replace broken ones. This includes:

- Boiler servicing to ensure boilers are as efficient as possible.
- Boiler replacement for items that are no longer suitable for use.
- Oil heating servicing and support for residents that use oil for fuelling their home.

- White goods provision. To supply replacement or new energy efficient items to households including cookers, fridges/freezers, washing machines/dryers, microwaves and other items as appropriate.
- Beds and mattresses to homes that do not have suitable bed provision.

## County Councillor Susan Carey

Following the meeting of Postling Parish Council on 24 September I sent my response to KCC Planning about the proposed Waste Transfer Station near Junction 11 of the M20 and emphasised points made by parish councillors. There may be amendments made to the proposal in response to comments from consultees and if these changes are significant then there will be a further opportunity to comment.

The new Government's Budget included announcements on extra funding for Adult Social Care, children with Special Educational Needs, continued funding the Household Support Fund which helps the most vulnerable and extra money for road maintenance. However, the increase in the Employers' National Insurance Contributions and the National Living Wage will increase KCC's costs particularly for the companies and charities we pay to deliver Social Care. The final settlement for Local Government will be confirmed in late December but we already know we will need to make substantial savings to balance the KCC budget for 2025/26. One of these savings is from ceasing the Wellbeing Service for Adults to save £3.45m annually. The Wellbeing Service includes an innovation fund to trial new approaches to care and Care Navigators who advise those over 55 on services. You can take part in this consultation and others at <https://letstalk.kent.gov.uk/> KCC has also just started a consultation with its staff to reduce staff numbers in order to make savings.

There was a paper about the preparations for the much-postponed European Entry Exit System (EES) at the meeting of the Full Council at KCC on 07 November. EES, which replaces passport stamping with a biometric system, was due to be implemented from 11 November but most EU countries (including France) are not yet ready. I spoke in the debate to make the point that our communities face regular disruption to our roads whenever there are problems with cross Channel traffic quite apart from the potential of long delays as people register for EES. More needs to be done to enable people to register away from the ports and to manage the Cross-Channel traffic, both tourist and freight, so it doesn't blight Kent's roads. You can read the paper and see the full debate on the KCC website.

If you know of someone in financial difficulty then do check the KCC website for KentTogether which pulls together all the various schemes on offer to people who may have financial problems. For those simply concerned about meeting their winter fuel bills, do see what support may be available.
